Explanatory Notes

If you are constructing a new dwelling in a rural area or have purchased an existing property that does not have a rural addressing number, you will need to apply for a rural addressing number to be allocated.

Rural Addressing numbers are similar to street numbers as they identify your property for visitors and emergency service vehicles. The number however is based on a measured distance, usually from the beginning of the road; this makes it easy for people to locate the property quickly.

For example the following address, 1286 Firth Heinz Road, is 12.86 km along the Firth Heinz Road measured from the Wooli Road at Tucabia. Anybody wanting to find your property only needs to set the trip meter on their car to '0' at the intersection of the Wooli Road and Firth Heinz Road and measure 12.86 km. Of course some roads are extremely long or you may enter the road from the other end. In either case you only need to find one number and measure from there.

All emergency services including Ambulance, Fire Brigade, Rural Fire Service and Police are familiar with this method of numbering and are supportive of it.

For a fee of \$39.95 (2019/20) Council Officers will allocate a number to your property and prepare a plate showing this number. Payment can be made at 2 Prince Street Grafton or 50 River Street Maclean or by post to Clarence Valley Council, Locked Bag 23, GRAFTON 2460. The number plate will be available at Council's Customer Service Centre for your collection. You will be notified of this once the number has been allocated and the plate prepared.

Privacy Advice
