Re: Application for Small Bar License by Mohawk & Beard Pty Ltd for Last Rights Bar 4/2-6 Yamba St Yamba, NSW.

Police object to the granting of this Small Bar license on the following grounds:

- 1) Police spoke with the Michael Ridout-Allen a director of the applicant company on Thursday 4 February 2021, by telephone at that time, Rideout -Allen stated they were planning a venue for bands to play, and he would supply police with a letter of intent in relation to the proposed business. To date this has not been received.
- 2) NSW Police believed a Development Application approval would be required from Clarence Valley Council for a licensed premise at the proposed location. I have been advised that that application has been refused.
- 3) Density: Police are concerned with the current density of liquor outlets per population in Yamba. Currently Liquor Outlets vs population is as follows:
 - The State average for all licensed venues per 100k of population is 195, Yamba is 510. The Mclean/ Iluka/Yamba/Lawrence Police sector is 358 and Clarence LGA has 219
 - The density in NSW for licence venues authorised for takeaway sales per 100k of population is 89.6, Yamba is 181, Mclean/Iluka/Yamba/Lawrence Police Sector is 190 and Clarence LGA has 120.
 - The density in NSW for Package Liquor Licenses per 100k of population is **30.1**, Yamba is 65, Mclean/ Iluka/Yamba/Lawrence Policer Sector is 69 and Clarence LGA has 39.8,
 - The density in NSW for On-Licenses per 100k of population is 104, Yamba is 329, Mclean/ Iluka/Yamba/Lawrence district is 167.4 and Clarence LGA has 96.
 - The density in NSW for Producer licenses per 100k of population is 20, Yamba is 49, Maclean/ Iluka/Yamba/Lawrence district is 230 Clarence LGA has 10.
 - The density in NSW for Hotel licenses per 100k of population is 23, Yamba is 32, Mclean/ Iluka/Yamba/Lawrence district is 51.9 Clarence 1904 51.

In considering these population comparisons it's also worth noting that approximately 50% of the population are recorded as non-drinkers of alcohol.




Liquor and Gaming NSW's Statement of regulatory intent regarding COVID-19 coronavirus as updated on the 1st June 2020 authorises all licensed venues to operate in a package liquor format as a response to the economic stress and uncertainty, adding further competition into this market would be detrimental to the wellbeing of the community

4) Alcohol related crime: The availability of alcohol is a significant contributing factor to the impact of alcohol related crime. The impact of alcohol related crime in the Yamba and Lower Rivers Police sector is above the state average in relation all incidents, particularly Assaults and Domestic Violence.


Alcohol Linking Monthly Report STATE: NSW (Jan 2020 to Dec 2020)

Adding further locations for the safe and supply of alcohol in the Yamba Township would be detrimental to the wellbeing of the Yamba Community and the broader Community.

- 5) Vunerable Communities: New South Wales has an overall Aboriginal population of 2.9%. The Yamba/Maclean/Iluka district has an Aboriginal population at 4.7% is nearly twice the state average. (Census 2016). Aboriginal and Torres Strait Islander peoples are less likely to drink alcohol than other Australians, but those that do drink are more likely than other Australians to:
 - a. drink at dangerous levels both over a lifetime and on a single occasion
 - b. go to hospital for alcohol-related conditions such as liver disease

(Australian Government Department of health October 2021)

adding further points of sale within Yamba township, would be detrimental to the well being of the Yamba community and the broader community.

- 6) Alcohol-Attributable Hospitalisations & Deaths: The alcohol-attributable death rate in Clarence Valley LGA is 22.5 (per 100,000 residents). It is higher compared to the average across all of NSW (20). The alcohol-attributable hospitalisation rate in Clarence Valley LGA is 407.1 (hospitalisations per 100,000 residents). This lower compared to the NSW average (542.1) Between 2014/2016 and 2017/2018, alcohol-attributable death in Clarence Valley LGA decreased by 13.5%. Between 2015-2017 and 2017-2019 financial year periods, alcohol-attributable hospitalisation decreased by 9%. By comparison, Inner Regional Australia (NSW) alcohol-attributable death decreased by 7.2%, and alcohol-attributable hospitalisation increased by 6.8%. In NSW by comparison, alcohol-attributable death decreased by 4.3%, and alcohol-related hospitalisation increased by 8.8%. adding further opportunity for the purchase and supply of alcohol would be detrimental to the wellbeing of the Yamba and broader community.
- 7) Road Trauma and Traffic Offences: The Coffs Clarecne P.D which encompases the Coffs Harbour LGA rated the fourth highest police district in relation to drink drivers for 2020, with 292 Prescribed Concentration of Alcohol Offences being detected.
 - a. **Alcohol related Accidents:** Coffs Clarence Police District responded to 57 Alcohol related accidents for 2020 at a rate of 31 per 100K of population, Lower Rivers Police Sector is 21.7, which is lower the state average of 35.83.
 - b. **Fatal Motor Vehicle Accidents:** The Clarence Vally LGA sufferred 4 fatal motor vehicle accidents in 2020 equaling the 2019 losses. A ratio of 7.89per 100K of population, twice the state average of 3.4, adding further points of sale within the Yaamba township would be detrimental to the well being of the broader community.
- 8) Scarce Resources: The state average for Police Officers per 100K of population is 17348 divided by 80.92 equals 214 Officers. Clarence Valley LGA equates to 101.5 officers and Lower Rivers Police Sector is 92 officers. The Lower Rivers Police Sector, which includes the Maclean, Iluka Yamba, Lawrence and surrounding townships is usually only serviced by one police response vehicle, adding further demand for policing resources would be detrimental to the broader Community.
- 9) Sustainability: NSW Police believes there is currently sufficent supply of alcohol to supply the local demand and any increase in licensed premises would cause sustainability stress on existing business, tempting those licensees or licensees of business entering the market to engage in practises that not aligned with the safe and responsible supply of alcohol, such risk taking would be detrimental to the wellbeing of the Yamba and broader communities.
- 10) Location: Is in close proximity to the Calipso Caravan Park which accommodates tourist to the Yamba township. A noisy late night venue would negatively impact on the sleeping habits of guests at the caravan park, make Calipso Caravan park less desirable and inpact on return patronage to the park

- 11) There is also a number of residental dwelling with in close proximity of the proposed venue. NSW Police believe that the proposed bar with a 2am license with live bands playing late into the night would be detrimental to the Yamba community. There us at least 40 individual dwelling within 200m radius, with the closest only 23m from the rear of the propose venue. See attached Sixmap images Annex A1, A2 & A3.
- 12) Current night Liquor business: There is very little night Music scene, within the Yamba township, with the only 3 venues able to trade past 12am. However none of these venues currently trade past 12am. Very few resturuants are open past 8.30pm. The noise of a band would travel further and impact on more premises due to the quiet and tranqual ambiance of the seaside village.
- 13) The venue: The applicant has nominated the venue will have a capacity of 120 patrons. Police have reviewed the proposed plans and note there is only 87.64 square metres of total floor space for the venue. The Kitchen & bar occupies 27.8 square meters, Green room & Stage 14.5 square metres and toilets of 6 square metres. This leaves only 39.3 square metre in the general bar area. Police request Clarence Valley Council or a suitably qualified Building Certifier to review permssible patron numbers in the venue. See atached floor plan Annex B

Considering theses issues and the approval of the proposed license at the proposed location would be and detrimental to the Yamba Community and the Broader Community.

If the application was to be approved, Police would request the following conditions added to assist in mitigating the risks:

The premises is to be operated at all times in accordance with a Plan of Management as approved by and which, may be varied from time to time after consultation with the NSW Police District Commander or his delegate A copy of the Plan of Management is to be kept on the premises and made available for inspection on the request of a police officer, council officer, or Liquor & Gaming NSW inspector

The Plan of Management is to address the following issues:

- Hours of operation.
- Patron numbers
- Induction and training
- Documentation
- Responsible service of alcohol
- Complimentary strategies
- Intoxication and anti-social behaviour
- Amenity of the local community and complaints
- Fire safety
- Security management plan
- Patron transport







ALCOHOL PLAN OF MANAGEMENT

PURPOSE

The purpose of this Alcohol Plan of Management and Security Management Plan is to reduce the harms associated with the sale and supply of Liquor by implementing effective control strategies.

GENERAL

The Alcohol Plan of Management incorporates the Security Management Plan. This Alcohol Plan of Management (& Security Management Plan) indicates the mode of operation for Last Rites in connection with the liquor licence.

PART 1 – HOURS OF OPERATION

The permitted trading hours of the premises are:

Monday to Saturday 11:30am – 11:30pm Sunday 11:30am – 11:30pm

Proposed hours of operation

Thursday	3:00pm - 11:30pm
Friday	3:00pm - 11:30pm
Saturday	11:30am - 11:30pm
Sunday	11:30am – 11:30pm
Monday	3:00pm – 11:30pm

Tuesday Closed Wednesday Closed

Proprietor's discretion to close earlier dependent on patron numbers. Discretion to implement weekend trading hours during peak holiday periods.

PART 2 - PATRON NUMBERS

In consultation with the Licensee, Police were informed it is the intention of the venue to trade with small groups of dinners/patrons of not more than 40 (COVID) in total and maximum 120 (post COVID, as per small bar regulation/allowance).

PART 3 – INDUCTION AND TRAINING

The Licensee (or delegate) will ensure all staff and security guards employed or undertaking security activities at name of premises & location will read and acknowledge the management practises of the venue by signing this document.

PART 4 - DOCUMENTATION

- 1.1. A copy of the license will be available, at the venue, for production at all times to NSW Police or other authorised Officers.
- 1.2. A copy of the Plan of Management and associated documentation (and Security Management Plan) will be maintained with the licence and available for inspection by an authorised officer.



- 1.3. Incident Register will be maintained.
- 1.3.1 The licensee/approved manager will establish and maintain an Incident Register and will ensure that all staff employed at the premises record in the register the following:
- a. Any incident in which a person is injured or requiring a person to be removed from the premises. Each incident is to be signed as correct by each security officer or member of staff involved in

the incident.

- b. The date and time the incident occurred.
- c. A description of the place at the premises where the incident happened.
- d. A description of each person involved in the incident and if known, the person's name.
- e. Details of the incident including for example, information about whether a person was removed from the premises because of the incident.
- f. Details of injuries sustained by persons involved in the incident.
- g. Details of action taken by a security officer or member of staff of the premises in response to the incident.
- h. Incidents both inside and outside of the premises including the immediate vicinity (50 metres) of the Licensed Premises.
- 1.4 The Alcohol Plan of Management is to be revised and implemented as required at the request of the Licensee or NSW Police. Agreement between both parties is required prior to the updated document being implemented.
- 1.5 The service of Alcohol will be to patrons only within the authorised area of the venue as approved by the authority and shown on the plans at the time of grant or after application to and approval by the Authority.

2. RESPONSIBLE SERVICE PRACTICES

- 2.1 The Licensee and all staff involved in the sale or supply of liquor will have current New South Wales Responsible Service of Alcohol (RSA) qualification.
- 2.2 An RSA register will be maintained and on hand at the venue. Photocopies of current RSA Cards are to be kept in the register.
- 2.3 No staff member will be allowed to commence duty or be involved in the sale or supply of liquor unless they have provided a copy of their RSA qualification or have shown the Licensee their current RSA Competency Card.
- 2.4 Staff with an RSA Competency Card must have the card available to them at all times when they are involved in the sale or supply of liquor.
- 2.5 Liquor will only be sold or supplied to persons of or above the age of eighteen (18) years.
- 2.6 Identification. Any patron appearing to be under the age of 25 will be asked to provide evidence of age. Only the following are acceptable evidence of age documents:



- A) A driver's or rider's licence or permit (issued by an Australian State or Territory or any foreign country) including approved digital format.
- B) Australian passport or a foreign passport issued by another country,
- C) NSW photo card (issued by Roads and Maritime Services NSW)
-) Keypass (over-18) identity card issued by Australia Post.
- E) Proof of age card issued by a public authority of the Commonwealth or of another State or Territory for the purpose of attesting to a person's identity and age
- 2.7 Alcohol Types. The following drinks are not sold or supplied on licensed premises:
- a. Any drink (commonly referred to as a "shot" or a "shooter") that is designed to be consumed rapidly
- b. Any ready to drink beverage with an alcohol by volume content of more than 7% other than wine.

During the time period specified above, no more than:

- a. Two alcoholic drinks (whether or not of the same kind), or
- b. The contents of one bottle of wine may be sold or supplied on the premises to the same person at any one time. In this condition "ready to drink beverage" means an alcoholic mixed beverage that is prepared by the manufacturer.
- 2.8 Alcohol sales are to cease 30 minutes prior to close time.
- 2.9. The following will be available at all times: Low alcohol drinks; Soft drinks, Water and Food.
- 2.10 Substantial food is to always be readily available, when every alcohol is being offered or available for sale, in accordance with Sect 17 of the liquor Act 2007. The kitchen will remain open whenever the Primary Service Authorisation is being utilised.

3. COMPLIMENTARY STRATEGIES

- 3.1 Staff Patrols. The Licensee (or manager) will ensure staff conduct regular patrols of the licensed premises to:
- * Speak to and interact with patrons to assess early signs of intoxication;
- * Monitor toilet facilities by regularly check those facilities for tidiness and patron well being.
- 3.2 Illegal drug use/Possession. There is a 'zero tolerance' stance on illegal substance use and possession for patrons and staff. Patrons identified by the Licensee, delegate, staff, police are to be removed from the Licensed Premise.
- 3.2.1 Staff illegal drug use/possession Illegal drug use and possession by staff will result in immediately being stood down from their rostered shift, removed from the licensed premise and employment offered counselling.
- 3.3 Liquor Accord Participation. Four Liquor Accords operate within the Coffs Clarence Police District. (Bellingen LGA Accord, Coffs Harbour LGA Accord



Grafton Liquor Accord and Lower Clarence Liquor Accord) It's recommended that venue join and participate in the relevant liquor accord.

- 3.4 Barred / Banned persons. Banned patrons are to be served a "Banning Notice" either in person by the Licensee, manager or delegate. Premise is to operate in accordance to the Coffs Harbour liquor Accord Banned Patron Policy
- 3.5. Pre-loading. Persons approaching and consuming alcohol outside the licensed premises are to be prohibited entry into the licensed premises.
- 3.6 Lighting. Lighting of all public areas of the premises including liquor service areas are to be sufficient to allow staff to observe the behaviour of patrons.
- 3.6.1. All exterior areas of the premise shall be adequately lit and these lights will be kept on until all patrons have left the immediate vicinity (50 metres) of the Licensed Premises.
- 3.7 Outlaw Motorcycle Gangs. Persons entering or found to be within the licensed premises wearing any form of clothing, jewellery or other accessory that displays or infers by form of word, colours, logo, symbol or otherwise that they are a member of a prescribed group, will be asked leave the licensed premises, and all police called to remove them as per claus 98 Liquor and gaming administration Act.

Prescribed Groups: Bandidos, Black Uhlans, Coffin Cheaters, Comanchero, Finks, Fourth Reich, Gladiators, Gypsy Jokers, Hells Angels, Highway 61, Life & Death, Lone Wolf, Mobshitters, Nomads, Odins Warriors, Outcasts, Outlaws, Rebels, Scorpions, Notorious and any similar group.

- 3.8. "Staff drinks" are not permitted unless authorised by Licensee.
- 3.7.1 Staff are prohibited from consuming liquor during working hours.
- 3.7.2 Staff wishing to socialise after their rostered shift must ensure they change their employment clothing. Turning of shirts inside out is not acceptable and the Licensee or delegate will ask you to leave the premises.
- 3.7.3 All staff and persons acting on behalf of the Licensee of are to be in full uniform which consists of;
- 3.9 Closed Circuit Television: A closed-circuit television system is to operate on the premises in accordance with the following requirements:
- a. The system must record continuously from opening time until one hour after the premises are required to close (or, in the case of premises that are not required to cease trading, continuously at all times)
- b. Recordings must be in digital format and at a minimum of 15 frames per second
- c. Any recorded image must specify the time and date of the recorded image



- d. The systems cameras must cover the following areas:
- i. All entry and exit points on the premises
- ii. All publicly accessible areas (other than toilets) on the premises.
- e. All recordings made by the CCTV system are captured for at least 30 days
- f. Recordings must not be tampered with, edited or changed in any way prior to handing to police or any other investigating official.
- g. Signage must be displayed indicating to patrons that closed circuit television is in operation
- i. Recordings are only viewed by an authorised investigator under the Liquor Act 2007.
- 3.10 Crime Scene Preservation. Immediately after the Licensee or a staff become aware of, or reported to, any incident involving an act of violence causing any injury to a person on the premises, the following is adhered to:
- a. The Licensee (or delegate) will take all practical steps to preserve and keep intact the area where the act of violence occurred, retain all material and implements associated with the act of violence in accordance with the Crime Scene Preservation Guidelines issued by the NSW Police.
- b. The Licensee (or delegate) will make direct and personal contact with the Local Area Commander or his /her delegate and advise the Commander or delegate of the incident
- c. The licensee and / or staff will comply with any directions given by the Commander or delegate to preserve or keep intact the area where the violence occurred. "Staff" in relation to subject premises, means any person employed by or acting on behalf of the licensee of the premises, and includes any person who is employed to carry on activities, including a crowd controller or bouncer, RSA Marshall on or about the premises.

4. INTOXICATION AND ANTI-SOCIAL BEHAVIOUR

- 4.1. In accordance with the Liquor Act and intention of the Licensee all staff are expected to be diligent in observing and acting on intoxication and anti-social behaviour in the licensed premises and with patrons entering and leaving the function.
- * Be alert to detecting signs of intoxication at an early stage;
- * Promote the free water being available;
- * Encourage alternate beverage options (such as soft drink, coffee, tea)
- * Ensure there is an ample supply of food available;
- * Be calm and courteous when dealing with customers;
- * Be alert to patrons who may attempt to purchase liquor on behalf of potentially intoxicated patrons.
- 4.3. When dealing with patrons who are becoming noticeably affected by liquor, Staff are expected to:
- * Identify that a patrons speech, balance, co-ordination and behaviour is noticeably affected by alcohol or drug.



- * Be calm and courteous:
- * Inform the Licensee, manager or security of the situation;
- * Where appropriate, explain their legal responsibilities to the person;
- * Where appropriate, explain the implications of the patron becoming intoxicated to friends of the person and who they may assist.
- * Refuse service of liquor.
- 4.4. When dealing with patrons who are noticeably affected by liquor or are acting in a manner likely to cause an undue disturbance to other persons or cause injury or other harm, staff are expected to:
- * Be calm and courteous;
- * Inform the Licensee of the situation;
- * Where Security Officers are employed, inform security of the situation;
- * Refuse service of liquor.
- 4.5. The Licensee (or a person acting on their behalf) will:
- * Be calm and courteous;
- * Where Security Officers are employed, inform security of the situation;
- 4.6. The Licensee (or a person acting on their behalf) will explain or arrange for the explanation to the person that:
- * Service of liquor is refused;
- * The person must leave the licensed premises;
- * The persons must leave the vicinity (50 metres) of the premises;
- * Call, or arrange for someone to call, police when the person refuses to leave or becomes violent.
- 4.7. The Licensee (or person acting on their behalf) will report all incidents of violence on or in the immediate vicinity of the Licensed Premises (50 metres) to Police.

5. AMENITY OF THE LOCAL COMMUNITY and CUSTOMER COMPLAINTS

- 5.1. All Staff will treat disturbance issues and complaints seriously and respond to them accordingly by:
- a. Identifying the nature and seriousness of the issue or complaint;
- b. Reporting the incident to the Licensee or their delegate / manager
- c. Assessing whether it can be dealt with by the staff member or if it requires the Licensee's or Security intervention;
- d. Establishing a resolution to the issue or complaint that, wherever possible, is mutually satisfactory;
- e. Documenting the details of the disturbance issue or serious complaints in the Incident register including: Time, date and location; Names (where known) of the persons involved; Details of the issue/complaint; Action taken.
- 5.2. The licensee and/or approved manager of the premises will ensure that the noise levels of patrons exiting the hotel precinct do not cause noise or inconvenience to the local residential community.
- 5.3 Staff will be tasked to monitor patrons exiting the premises at closing time to ensure they do so quietly and orderly.



5.4. The Licensee, Security and Staff will make requests for patrons to leave quietly and consider the local community during and on ceasing trade.

6. FIRE SAFETY

- 6.1 All exit lights and exit signs are kept in good working order at all times.
- 6.2 Staff is to ensure that exit paths to outside the premises are kept clear of obstruction at all times.
- 6.3 The Licensee (or delegate) is to prepare an emergency evacuation plan and all staff will be trained in its implementation.
- 6.4 All fire extinguishers and hose reels will be checked by a qualified contractor every six months.

SECURITY MANAGEMENT PLAN

GENERAL

The Security Management Plan forms part of the Alcohol Plan of Management.

1. COMPLIANCE

- 1.1. Security guards engaged to provide a security activity at the venue will be engaged through a current NSW Security Master Licence holder.
- 1.2. A copy of the Security Master Licence will be maintained in the Security Incident Register.
- 1.3. Security guards engaged to provide a security activity at the venue must:
- * Hold and display a current NSW security licence;
- * Have current NSW RSA certification:
- * Provide RSA Competency Cards. All cards must be shown to the licensee and be available for inspection at all times;
- * Provide a photocopy of the RSA competency card to the licensee, where it will be kept in the RSA Register.
- * Wear a uniform displaying that they are Security guards;
- * Wear a clearly identifiable shirt, jumper, jacket, vest with the word
- "Security" clearly printed on the shirt, jumper, jacket or vest.
- 1.4 All Security at the venue are to be employed or contracted to perform security duties/activities at the venue. No security shall perform duties on a "volunteer basis"

2. SECURITY DUTIES

- 2.1. Duties will include, but are not limited to:
- * Assisting the Licensee with strategies employed to improve safety and reduce intoxication and anti-social behaviour;
- * Proactively monitoring crowd numbers and behaviour;
- * Proactively monitoring access areas to the hotel;
- * Proactively checking evidence or age;
- * Proactively report concerns to the Licensee:
- * Assisting the Licensee and Staff or solely dealing with intoxicated, difficult, unruly or violent patrons;
- 2.2. Security personnel undertaking a security activity at the venue are to (in a reasonable time frame) record all intoxicated patrons refused service, have violent confrontations with patrons and all incidents where patrons have been forcefully removed from the premises in the Incident & Security Incident Register.
- 2.3. Security personnel undertaking a security activity at the venue will assist police with their enquiries investigating crime thus ensuring compliance with the Security Industries / Liquor Act and associated regulations.



2.4 All security personnel wishing to socialise after their rostered shift must ensure they change their employment clothing. Turning of shirts inside out is not acceptable and the Licensee or delegate will ask you to leave the premises.

SECTION 4.15 EVALUATION FOR DA2021/0116 - Lot 2 DP 506131

Lot 1 DP 506131- 2-4 Yamba Street YAMBA NSW 2464

Proposal: Development Application DA2021/0116 seeks approval for a Small Bar and Restaurant in an existing shop at 2/4 Yamba Road Yamba. The premises is known as the "The Last Rites Bar". The bar and restaurant will have a small stage area for live music entertainment.

(1) Matters for consideration - General

In determining a development application, a consent authority is to take into consideration such of the following matters as are of relevance to the development the subject of the development application:

- (a) the provisions of:
 - (i) any environmental planning instrument, and

Clarence Valley Local Environmental Plan 2011

The subject land is zoned B2 Local Centre under the provisions of the Clarence Valley Local Environmental Plan 2011. Restaurant/cafes are a type of food and drink premises and are a permissible use within the B2 zone. An extension to the existing premises is permitted subject to the consideration of a development application. The following definitions apply:

restaurant or cafe means a building or place the principal purpose of which is the preparation and serving, on a retail basis, of food and drink to people for consumption on the premises, whether or not liquor, take away meals and drinks or entertainment are also provided.

Note. Restaurants or cafes are a type of food and drink premises—see the definition of that term below.

food and drink premises means premises that are used for the preparation and retail sale of food or drink (or both) for immediate consumption on or off the premises, and includes any of the following:

- (a) a restaurant or cafe,
- (b) take away food and drink premises,
- (c) a pub,
- (d) a small bar.

The proposed extension to the existing food and drink premises is consistent with the following objectives of the B2 Local Centre Zone:

- To provide a range of retail, business, entertainment and community uses that serve the needs of people
 who live in, work in and visit the local area.
- To encourage employment opportunities in accessible locations.
- To maximise public transport patronage and encourage walking and cycling.
- To reinforce and support the central business districts of Maclean, Iluka and Yamba as the commercial centres for these towns.
- To minimise conflict between land uses within the zone and land uses within adjoining zones.
- To enable other land uses that are compatible with and do not detract from the viability of retail, business, entertainment and community uses within the zone.

Signage for the premises will be required to be exempt under the provisions of the Schedule 2 of the LEP otherwise a separate DA will be required to be lodged.

Clause 7.8: Essential Services

The subject site has access to reticulated water, electricity and sewer. The site has access to Coldstream Street, a Council maintained road.

State Environmental Planning Policy (Coastal Management) 2008

The subject land is located within the Coastal Zone and Coastal Environment Area under the Coastal Management SEPP. It is considered that because this application is purely for an outdoor dining area there will be no likely impacts from the development on any of the coastal areas and the development is consistent with the aims of the policy.

The proposed development is not inconsistent with the matters prescribed within the Regulation.

(b) the likely impacts of that development, including environmental impacts on both the natural and built environments, and social and economic impacts in the locality.

The proposed development will have limited environmental impacts on the natural and built environment as the intended changes to the premises are minor in terms of internal additions required to support the intended changes. The proposed development will generate some economic activity within the locality and create employment opportunities. There may be minor economic benefits if local labour, materials and produce are used within the proposed development.

The social impacts to adjoining residences has been considered and through the proposed noise attenuation methods and an overall reduction in the hours of operation, any potential impacts to neighbouring residences will be minimised.

(c) the suitability of the site for the development,

The site is suitable for the proposed development subject to the imposition of suitable conditions to ensure noise does not adversely impact on the amenity of the neighbourhood above unacceptable levels.

(d) any submissions made in accordance with this Act or the regulations,

There were 45 submissions received during the notification period. Many submissions were received in support as being a much-needed music venue for local musicians, the local community and visitors. The submissions against the proposal raised issues in regard to noise, alcohol related issues and the impact on the amenity of the locality, alcohol licencing and car parking/traffic generation. Notably the NSW Coffs/Clarence Police District Licensing Sergeant has objected to the proposal.

Issue 1 - Noise impacts

There are two main areas of concern from potential noise; 1) impacts stemming from amplified music 2) number of patrons onsite and entering and leaving the premises

In response to the concerns raised within the submissions, the applicant proposed the following measures to reduce noise from the premises:

- Implementing up to \$15K for sound reduction and mitigation
- \$6K in CCTV security systems and lighting
- Consultation with NSW Police
- Patrons will be inside the premises at all time; the proposal is not seeking footpath patronage as is the case for other venues in Yamba

- There is adequate available parking, public transport options
- Patrons will be provided with substantial meals with food being available up to 30 minutes prior to closing
- There will be a zero tolerance to anti-social behavior on and around the premises

Comment

The specific details on the noise reduction and mitigation will need to be provided to Council's satisfaction prior to allowing the premises to operate. This is likely to include soundproofing measures of sound insulation, management measures and sound-proof glazing. A condition of consent is proposed to require that sound proofing measures adopted are to be supported by an acoustic consultant's report that determines that the measures in place are adequate to protect the surrounding locality from nuisance or offensive noise.

Similar to requirements imposed on other premises, any noise emitted from the premises will be required to not to exceed 5dBA above background noise which is in accordance with the NSW Industrial Noise Policy. If the premises is determined as emitting offensive noise once in operation, the applicant is required to engage an acoustic consultant to assess the noise limits and any recommendations suggested to reduce any impacts will be required to be implemented.

The proposal will also be conditioned that the noise level emitted from the premises must not exceed the background noise level in any Octave Band Frequency (31.5Hz – 8kHz inclusive) by more than 5dB during opening hours, at the boundary of any affected residence. This is also consistent with the NSW Industrial Noise Policy Guidelines.

Issue 2: Hours of Operation

Concerns have been raised within the submissions regarding the existing hours of operation and impact of late nights to the amenity of the neighbourhood.

Comment

Similar to other bars and restaurants in Yamba the hours of operation will be set so that the businesses are on a level playing field. The hours of operation on Sunday to 11.30pm is not supported and the premises will be required to be closed by 10.00pm on a Sunday.

Issue 3 – NSW Coffs/Clarence Police submission

Concerns have been raised in regard to the approval of another licenced premises in the Yamba CBD with the current density, number of patrons and the potential for increased anti-social and other alcohol related issues such as alcohol related crime, impact on vulnerable communities, alcohol attributed hospitalisations and deaths, road trauma and traffic offences and limited Police resources

Comment

A food and Drink premises is a permitted use in the B2 local Centre Zone under the Clarence Valley Local Environmental Plan 2011 (the LEP). The issue of a liquor license to a premises is a matter for NSW Justice - Liquor and Gaming and in recent years the liquor licensing of small bars and restaurants has changed to simplify the process of obtaining a license. In issuing the liquor licenses the NSW Justice - Liquor and Gaming has significant penalties for premises that are in breach of their license and to indirectly control anti-social behaviour.

The impacts that alcohol related activities have on the community are a valid concern though the issues go beyond the approval process of developments like this. The consumption of alcohol cannot be regulated through the planning and approval process. To refuse a development application based on a predetermined view that the operation of the premises is going to be detrimental to the wellbeing of the Yamba and broader

community is not a valid planning reason to refuse the development. The NSW Police submission also provided suggestions that if the proposal was approved. These have been included and satisfactorily addressed through the proposed management operations and proposed conditions of consent.

<u>Issue 4 – number of patrons</u>

Concern has been raised regarding the available area in the premises and the maximum proposed patrons being up to 120 at any one time.

Comment

A general bar liquor license limits the number of patrons to no more than 120 in a venue without gaming machines and does not restrict patrons on a per metre squared basis.

Under the National Building Code a restaurant is deemed to accommodate one person per every square metre of floor area. The available floor area (with tables and chairs removed) is calculated to be just under 50m2 available floor area. For this reason the maximum number of patrons will be limited to 50 patrons at any one time.

(e) the public interest.

The public interest has been considered as part of this application and through the implementation of the proposed conditions of consent, any potential land use conflicts between the premises and surrounding residences will be reduced.
