Re: Request for Support for a Moratorium on Mining in Areas Affecting the Clarence River Catchment.

Further to your letter dated 12 May 2021, please find following Council's Resolution as decided "unanimously" at its 23 June 2021 - Ordinary Council Meeting.

Resolution 135/21

<u>"Resolved</u> that Council <u>does not</u> support the Clarence Valley Council in its following motion - items (1) thru to, and including (5), and excepting item number (6):

- (1) Note that at the Council meeting on November 24 Council resolved inter alia to "oppose mining in the Clarence River Catchment and to seek the support of both state and federal governments to impose a moratorium on further mining exploration licences and to cancel existing licences."
- (2) Acknowledge that this motion does not affect existing mines or quarry operations;
- (3) Thank the Hon. John Barilaro for his response on behalf of the Minister for Energy and Environment, Hon. Matt Kean MP and advising that Council was not seeking an explanation of the process of developing mining in the Clarence River

- (4) Advise Hon. John Barilaro that the council, representing the community's strong opposition to such mining, is asking for the Clarence River Catchment to be scheduled in the relevant environmental, planning and mining legislation as a no-go zone for minerals mining due to the Catchment's almost unique natural and cultural values, many of which depend on the Clarence River and its tributaries, and which support essential and valuable industries which contribute to the local economy as well providing drinking water for the Clarence Valley (51,000 + residents) and Coffs Harbour City Council (76,000 + residents) and water for local agricultural industries;
- (5) Write to the Premier of New South Wales, the Hon. Gladys Berejiklian advising her of Council's resolution and seeking her support for a moratorium on mining in the Clarence River Catchment; and
- (6) Write to Clarence Valley Council to advise of Council's resolution."

Thank you for copying me in on your letter to the Premier in regard to a resolution passed at Clarence Valley Council's Ordinary Meeting on 22 June 2021 supporting a request from the Lawrence Bridge Action Group who are advocating for a funding commitment for a new bridge to be built at Lawrence to replace to Bluff Point Ferry.

I would certainly support a proposal which has the overwhelming backing of the local community, is safer and is clearly beneficial to the future growth of the area.

A new bridge will certainly see increased traffic through Lawrence and will have a profound impact on the village, so the community must be well informed about the impacts, both positive and negative. There would also be a need to upgrade the road between Maclean and Grafton because of the additional traffic a bridge would generate.

I am yet to see full details of the viability and cost benefit analysis undertaken by TfNSW and will endeavour to acquire this document.

In the meantime, I will follow up on Council's approach to the Minister for Regional Transport and Roads, Paul Toole, as any such proposal would fall under his remit.



- gathering for a wedding or funeral
- providing emergency assistance to a person
- fulfilling a legal obligation

moving home or moving your business to a new premises.

n NSW, you must also wear a face mask on **public transport** and in all **indoor non-residential settings**. This includes in:

- retail or business premises that provide goods or services to members of the public who attend the premises, including
 - supermarkets
 - shopping centres excluding an indoor recreation facility in a shopping centre
 - bank branches and post offices
 - o hairdressing, nail, beauty, tanning and waxing salons
 - spas, tattoo parlours and massage parlours
 - betting agencies
- any part of a licensed premises that's used for the purposes of gaming, and gaming lounges
- entertainment facilities
- places of public worship being used for public worship or religious services
- residential aged care facilities
- gym classes or dance classes
- indoor recreation facilities, unless you are doing strenuous exercise
- major recreation facilities

You must wear a mask if you:

- work a hospitality venue in NSW and
- directly deal with members of the public

Action: It appears that all this will make Hall Nights out of the question for the moment as you cannot gather even outdoors with more than 10 people. We will need to place signs up to remind people that they must wear masks while they are inside. Tracey to make signs and place them in the hall.

Initial research shows that there would be no initial set up costs and the lowest monthly fee approx. \$50 per month. We could start on a lower plan and expand on this for the festival and then lower it again afterwards depending on need.

Action: Further to this from last month – this has not been followed up so Nadine (Ewingar Rising) will organise for this to be installed.

Action: Michael to supply Tracey with account details so that enquiries can be made. May need to speak with past committee members to get more info. Tracey to bring her phone down next time and test it out and then follow up. This also has not been followed up so will remain on the agenda

- WHS and Fire Safety: Irena has reported that when she was here with the craft group a fire safety group of some decription turned up doing a compliance test. It appears that there are a lot of issues such as:
 - * chairs etc being stored too close to fire extinguishers must be at least 1.5 meters away
 - * Exit doors do not comply too hard to open in a hurry.
 - * furniture placed in front of doors

We believe that their findings will be sent to council and that council will address it.

 Basketball Hoop – can we cut it off at ground level and place a smaller sleeve on the bottom of the pole to enable it to be removed when the space is needed eg: Stage for Ewingar Rising. General consensus was that it was Council who put it in so probably not – however the question could be asked to council if we had any contact details –

Action: Secretary to seek council details and make enquiries or delegate for someone else to follow up.
