	As a committee member/ team manager and player of multiple sporting organisations and teams for more
	than a decade, I have a significant base of knowledge
	of what is required by many different sporting codes
	in the Clarence Valley, both in facilities and in

management from council.

I support the desire to allow multiple sporting organisations to be able to use the same venue where the sports involved would create a similar wear and tear on the playing surface so that the use by any of the organisations does not then cause such damage to the venue that is is not safely able to be used by other organisations. An example of similar wear and tear would be the use of Field 1 at Rushforth park being used by social and competitive soccer as well as touch football: each of these sports involves players wearing football boots, running with minimal sliding or diving on the surface and subsequently would cause similar damage. The potential problem that could occur if such precautions were not taken can be demonstrated by the extreme case of comparing the types of wear and tear on facilities created by pony club compared to soccer and compared to croquet. Croquet needs a very smooth surface, similar to lawn bowls greens in order for the game to be played and soccer needs a flat surface free divots for player safety. If at some unknown time in future, the pony club was to book field 1 at Rushforth park, which is allowable under the proposed amendment with the current wording which has no limitations on sporting organisations, then the playing field would be unsafe for all soccer events until the surface is repaired, disrupting competitive, social and school events and costing money to repair and loss of hiring fees to council. Similarly if a soccer team was to train at the croquet club venue, the venue would be unusable until significant repairs occurred. Numerous examples could be created using the different fields and organisations in the Clarence Valley and so the need to consider the wear and tear is paramount.

I feel it is essential that the amendment has to include unambiguous wording that ensures venues are able to be booked by organisations that will create a similar wear and tear on the surface and will not cause wear and tear that would prevent other organisations from using the venue.

With this in mind, I also believe the clause below needs to remain.

In cases where a conflict arises between different sporting organisations and/or with staff, they may be referred to and resolved by the Director responsible for Open Spaces & Facilities or an alternate staff member from the executive team (an alternate Director or the General Manager) in consultation with said sporting organisations. At the Directors discretion, this may include a meeting between the sporting organisation and/or staff with the meeting facilitated by the Director.

This process would protect venues from the ambitions of organisations to access venues where their use of the venue may damage it and prevent the use of the venue for others. I am in no way saying organisations choose to do this on purpose but it is unavoidable that extended wet weather events occur in our region and sporting organisation coaches and managers are often searching for alternate training and playing venues during those extended periods. In these situations there needs to be a strong process that protects the integrity of what is left.

At the current time, all sporting organisations in the Clarence Valley are aware of the primary user sport type of venues and the arrangements that have been in place and respect those arrangements. In 3 to 4 generations time, such knowledge will no longer exist and it is the wording of the policy and the processes around it that will protect the venues. The desire to increase the use of venues to as many sports as possible is commendable as the importance of sport

to community health and mental health cannot be understated, but it is essential that the wording around the amendment be unambiguous and the processes around the policy be strong so the amended policy is an absolute good for the people of the Clarence Valley now and for our grandchildren's grandchildren 100 years from now.

Comments	I do not believe converting all the sports fields to
	multi-use will be in the best interests of the CVC or
	regular user groups of the facilities. Each facility was
	designed and built for a specific purpose and may not
	be able to safely accommodate everyone who wishes
	to use them. For example, the hockey fields were not
	designed to have people with certain shoes on
	running all over it, the surface of the netball courts are
	not designed to accommodate anything with wheels,

or certain types of shoes. If a user group damages a field / court, the cost to fix could be quite high and would be the responsibility of the CVC. Does the CVC have the money in its budget to undertake all these possible repairs? Repairs quite often cannot be delayed significantly due to the safety risks they pose. Participants could very easily fall / trip and injure themselves as a result of a crack, divot, hole etc that has been made on the playing surface. If this happens, is the CVC willing to accept liability? Apart from the safety issue, damage makes a facility look unkempt and untidy. Many of the sporting groups in the Clarence Valley pride themselves on their excellent facilities and put a lot of effort into keeping them in close to pristine condition. If facilities are opened up for anyone to use, is everyone going to be part of the maintenance of the facilities? I doubt a casual user will care if a facility needs cleaning, even though they contributed to the dirt / mess that needs to be cleaned. COVID-19 also must be taken into consideration. Will casual users clean and sanitise everything to acceptable standards after use? I accept that CVC may place rules on using facilities, but if fields / courts are going to be truly protected from damage / mess then there needs to be a long list of rules, for example, what shoes can be worn on playing surface, what equipment can be used on the playing surface, what specific activities are allowed to happen, what needs to happen with rubbish and cleaning, what items / equipment stored at the facility can / cannot be touched. Such rules are the only way to prevent potential damage etc from occurring. Unfortunately the list of rules would need to be so comprehensive for each facility, that it's not worth making everything multi-use. Perhaps the CVC can look at spending money on building a few additional facilities (such as a bike track for casual users) instead of spending money on extra maintenance / repairs / signage etc that will be required if facilities

### are multi-use.

Submission to Clarence Valley Council re draft amended Sports Management Policy submissions close 23 September 2021

The Grafton Rugby Union Club have a number of concerns with the draft amended Sports Management Policy.

I write on behalf of the Grafton Rugby Union Club that represents currently over 300 players from the Grafton community from juniors, senior grade and 'old boy' male and female teams and additionally numerous mums, dads and families that regularly use the Hay St fields, otherwise known as the Grafton Rugby Park.

#### Significant capital investment in the Clarence Valley and rugby union

The facilities commenced construction by the Club's volunteers in the late 1970's with the construction of both fields and field lighting by the Club. All major capital improvements since then have been initiated by and paid for by the Club alone through a combination of Government grants, fund raising, club funds and community volunteer generosity.

In 2005, after support and approval from Council, significant capital investment (approx. \$390,000) was made by the Club to construct new storage, changerooms, Rugby Club rooms, field leveling and irrigation systems, ground lighting improvements and sewer pump station connection. This incorporated \$152,000 in Federal and State Grant contributions, \$50,000 in club funds and fundraising and over \$170,000 in in-kind community contributions and volunteer manhours. Council contribution to this project was only made by waiving of Construction certificate and certifier fees to the value of \$845.00.

Since this time, the club have contributed significantly to maintenance of all buildings, ground lighting, field line markings (supported and confirmed in agreement by Council in writing in August 2004).

Council have provided little if any capital improvements at the fields over this time. Over recent years only bollards have been installed delineating the extent of the ground and footpath. As part of ground booking fees Council now maintain the main field irrigation system, toilet pump station, and provide field mowing, wheely bin garbage removal and line marking paint.

The draft policy does not recognise the value of past capital improvements provided by Clubs such as the Redmen, directly or indirectly (through non-Council grants), thereby allowing some groups (and Council through its hire charges) to benefit from those improvements provided by the group (such as the rugby union club). We are of the opinion that if Council are going to charge for multi-use of such facilities, the group that provided those capital improvements should get some fair recompense for having provided those improvements, either through cheaper (or nil) ground hire, or if the same fee is to be provided, through capital reimbursement. Otherwise, there is little incentive for Clubs to invest their own funds and time into capital improvements if other groups can then hire and benefit from those facilities at the same hiring fee.

#### **Rugby Union usage**

All of the abovementioned capital improvements have made the rugby fields high-quality and to current NSWRU and Australian Rugby Union standards. These fields are currently used primarily for rugby union including;

- night training (Monday- Friday during winter and Tuesday-Thursday less frequently during summer from about November),
- scheduled competition games (Friday nights and Saturdays),
- preseason rugby union knockout days,
- school rugby union carnivals by all Grafton Schools throughout the year
- inter district rugby coaching clinics, being a central location on the north coast with capacity of two fields.

The above represents a serious economic benefit provided by rugby union to the local Clarence Valley economy.

### Multiple and compatible use

The fields are also used by other compatible sports during the winter season and during the summer months including Oztag (approximately 400 members), South Grafton Rebels Senior Rugby League preseason trial games (whilst their home grounds are being used for cricket), occasional school touch and rugby league games and regular passive recreation and practice. These groups have used the fields and changerooms with concurrence and under supervision from the rugby club to ensure security and integrity of the facilities and appropriate behaviour.

I attach a number of letters of support used for a recent sporting grant which testify this multi-use approach to the fields by the club. This has always been the approach by the club; as long as concurrence is obtained from the primary user (rugby union club), and those users book the ground and look after the facilities.

### Incompatible use

#### The Fields:

The club has previously worked with other clubs for the use of the fields; however, some of these have proven incompatible with rugby union. Examples include: the dog clubs holding weekend dog trials on the field. Unfortunately tent pegs were left in the field on a number of occasions and rugby players were seriously injured following these events. The horse clubs have also used the grounds previously which led to long term damage of the field surface, and subsequent player injury.

The club would object to any incompatible sports use of the fields given both our historical use and capital investment in the facilities. This would also likely reduce financial burden on Council and the club to repair and maintain infrastructure and facilities.

#### The Rugby Union club rooms:

In 2005, the Rugby Union clubhouse were built with the full knowledge and support from Council through an approved Development Application (10.2003.76.1) and support of the Grant application, with the club rooms being an integral part of the approval. As such, we would <u>strenuously object</u> to Council hiring out the Club rooms without the Club's concurrence. <u>The Club</u>

prefer that management of the Club rooms be left in the hands of the Rugby Club. It should be noted that Council, being land manager of the reserve at the time of construction in 2004/05 (and now) had the opportunity as land manager to object/not approve private Club facilities on the land that they control. In not doing so, the Club has expended significant funds on that basis to cater for and improve the needs and requirements of the rugby union club; and would not have done so without security of tenure. To change that arrangement now, is not justifiable.

Additionally, the size of the club rooms does not lend to open use by other sporting groups. The Club have provided limited use in the past, however despite supervision and guarantees, expensive gear has continually been stolen or broken and not replaced by other users with inappropriate behaviour. This has placed both an unnecessary manpower and financial burden on the club to manage.

#### Rugby union primary use with compatible use by other sports

The Rugby Union club ask that the primary use of the fields be maintained for rugby union. The club have consistently shown through the years that it is willing to work with other community sports that are compatible with rugby union. This is in terms of using the existing rugby field markings and field dimensions.

The club would also object to any proposal to let other sporting markings on the field. Other sports use of the fields has previously worked within the current rugby union field markings; and if required used temporary moveable cones to delineate their sport on the playing surface without determent to the primary field use (ie rugby union). We have some concern that multiple ground markings may impact upon our ability to secure finals series matches as ground presentation is an important factor in our governing body's finals series allocations.

As with historical and existing arrangements, on behalf of the players and supporters we represent, we request that any other compatible sports consult Council and the rugby club prior to booking and usage to use the fields and changerooms to avoid any issues.

Further that, Council do not hire the Rugby club rooms and their use is left to be managed by the Rugby Union Club.

This is consistent with other community sports who maintain the primary use of their home fields in the Valley and we feel that it is also consistent with the intent of the multi-use policy.

I write in support of an application for funding by the Grafton Rugby Union Football Club under the NSW Government's Local Sport Grant Program to improve facilities at their playing and training fields.

The Club wishes to replace the dilapidated goal posts on the training and secondary playing field which do not meet current safety standards. Grafton Oztag Association are writing to express and show our support for the application for an up-grade of the lights and goal posts at Grafton Redmen Rugby Union Club at Hay St, South Grafton.

We have had a long association with this club over many years in coordinating our sporting group of over 400 members. We know first-hand how devoted they're to the improvements and to continually maintain the sporting facilities for accessibility for both adult and children of varying sports and clubs in the betterment of the community.

Grafton Oztag utilise the grounds on Monday evenings from 5:45 pm to roughly around 8:40 pm and the lighting is of poor quality which makes visibility during the game difficult. The standard of lighting is outdated and is in constant need of repair due to their age. Our association would assist gratefully with the inclusion of new lights during the Summer period and obviously in the Winter period that Redmen (Senior and Junior Clubs) operate. Also, improved and more efficient lighting will enable power saving and reduce our electricity costs that our association spends each season.

The goal posts are also in desperate need of being replaced. They are aged, worn and somewhat of a safety issue. With this NSW Community Building Partnerships grant, the replacement would be a major benefit to all sporting clubs, schools and the wider community alike.

By utilising these fields and facilities all year round many sporting clubs benefit and we believe by upgrading the current lights and the goal posts (both in need of replacement), that this is a wise investment for NSW Government to support this well-rounded, supportive and community driven club.

As far as the CVC not being able to apply any further maintenance to the facilities of GHA, we as an entity already employ staff to ensure that our facility is maintained, as per our lease agreement, with no extra help from the CVC. If these changes were to be implemented, extra resources would have to be poured into the maintenance of both the GHA Buildings & Turfs, noting that recently we had to expel over \$21,000 to clean a single turf, as well as Lower Fisher Park. Lighting costs have also been incurred to the association this season, at zero cost to the CVC. We as an association are one of the largest sporting organisations in the Clarence, hosting hundreds of memberships, we are already enduring a hardened time running the association due to the current COVID environment, and these changes have the potential to drastically influence the way our association operates.

We as an association urge the CVC to reconsider, or revise more appropriately, the new proposed Sports Management Policy for the greater good of the sporting community in our Clarence, and we are not the only ones.

Comments	Ever since I was a child I have played soccer at Rushforth Park. My father and Uncle (now deceased) were life members of City club. They raised the funds and did the work (Bill was an electrician) for the new fencing and lights that were installed when the new fencing went in. My father's ashes were spread in the goal mouth of field 1. I was a junior referee and am now a coach. Field 1 has been shared by Rushforth Park Town

Clubs and Grafton SOS during the winter for many years - DECADES. This is the first time we have been prevented from using it.

Rushforth Park Fields 2 and 3 are unsatisfactory for Grafton SOS Winter Games.

- Field 2 and 3 are vastly inferior to Field 1 in terms of playing surface and lighting.
- Both fields are used for training during the week and this has caused considerably on one corner of field 2 which has been used for shooting and corner practice by RPTC teams. Practice is much harder on these areas of the playing surface than the games themselves due to the repetitive nature of practise)
- Field 2 is some way from the Canteen, toilets, internal room and shelter which is a real issue in cold weather.
- On Field 3 the goalposts would have to be dragged some distance in the dark at the start and end of our games, whilst the drainage and the discharge from the gutters of the new building that run directly across that field would mean we would almost certainly lose more games due to a boggy field.

The effect of this ban on Grafton SOS has been dramatic:

Player numbers have dropped due to distance from the canteen, toilets and a warm, dry place for children and spectators during wet and cold weather, and poor playing surface and lighting.

The Misfits winter team has folded due to lack of players meaning another team has to have a bye. Fewer players have been coming to the canteen due to its distance from the games and canteen takings have collapsed. The social aspect of the club has been significantly reduced.

The fields have been paid for by us, as both local rate payers and as taxpayers. It is wrong that we are being

prevented from using facilities we have helped pay for. The council policy itself states that the fields are "The sporting facilities are multi-use, allowing a much wider use of the grounds." This decision makes Field 1 a single use, single organisation field. Council staff have given RPTC exclusive use against it's own policy. The existing policy states that the council is intent on providing equitable use of its sports fields and facilities for all users. Our competition allows middle aged and older players of all abilities, genders, ethnic groups and disabilities the opportunity to play in a friendly and inclusive competition. Council is discriminating against our players. The council strategic plan states that council will "1.2.1 – Provide, maintain, and develop sport and recreational facilities and encourage greater utilisation and participation" yet the actions of Council staff have reduced utilisation and participation.

According to the NCF website there are only 51 games scheduled for Rushforth Park Field 1 this season and of those only 28 under lights. This is a very poor use of this expensive facility which is lying idle when we wish to use it. In comparison, Grafton SOS has over 100 games scheduled during our Winter season, which equates to more than tripling the users and doubling the time of the facility usage when allowing for the fact we play 2 x smaller fields on field 1 at a time, and finish 4 games in 2 hours rather than 1. Our use of these smaller layout also completely eliminates any wear and tear on key areas of the pitch such as the centre circle, goal mouths and corners of field 1 which would be inevitable if we elected to resort to running 4 full field games in order to use field 1.

Comments	Grafton Netball Association opposes the changes to the Sports Management Policy (Version 3.1) as detailed in the draft currently on exhibition.
	Firstly, we are concerned with the potential damage that could be done to not only our courts, but to other sports facilities, if multiple users are permitted. Each facility has been purpose built for a specific sport (or sports) and using facilities in a way for which they

were not designed or built risks damage. In our situation the netball court surface is not designed to accommodate equipment with wheels, such as bicycles, roller skates, skateboards, and the like, nor equipment that would probably be dragged over the court, or hit into the court, such as portable soccer goals, volleyball nets, hockey sticks and the like. The court surface is acrylic (the same material as used on tennis courts). A reputable manufacturer of acrylic court surfaces states, "Keep bicycles, lawn mowers, battery powered child vehicles, etc. from traveling across the surface. Roller skates, skateboards, inline skates, or roller blades are not advisable to be utilized on outdoor tennis court(s). All of these mentioned can lead to scuffing, marring, or scratching to the acrylic color finish. Keep furniture (chairs, tables, etc.) ladders, ball machines not in use, etc., off the outdoor court(s). They can leave indentations in the outdoor court(s) surface if they sit for long periods of time. Additionally, any leg bottoms or supports must have flat bases if they come into contact with the outdoor court(s) surface. If they are not flat or in proper condition, they can scuff and scratch the acrylic color finish." (Latex-ite Recreational Coatings). Not only is damage expensive to fix, but it also makes the courts unsafe to play on. Cracks, divots, indentations, scratches, or anything else that causes the court's surface to lose smoothness, can cause players to trip or fall, leading to injuries. In fact, "injury to users / spectators due to conflicting activities" is listed as a critical risk of a sporting facility in Clarence Valley Council's Resourcing Strategy document (June 2021, p. 127).

Additionally we believe that making the facilities multiuse will potentially render them not fit for purpose. Sporting facilities such as the Grafton Netball Courts were designed and built for a specific reason and not with multiple users in mind. The Netball Australia

National Facilities Policy – Technical Manual (2016) states that "the court must be fit for purpose" (p. 16). It also recommends to "ensure court works are designed specifically for each site" (p. 30) and that "If the courts are part of a multiple court Association facility it may be beneficial to have adequate change room/toilet facilities in close proximity." (p. 32). The courts were designed and built to be used to play netball. No other sport or use was ever intended. The facility is not designed to accommodate other user groups. Furthermore, as netball is a female dominated sport, the courts only have one men's toilet, which would not be sufficient if the facility was used by a group with a significant number of males.

Pursuing this further, we understand that it is the intention of Clarence Valley Council to update the line markings on the courts to enable them to be multi-use friendly. Having several lots of line markings will be incredibly confusing for all players and umpires. This could lead to injuries if players are using the incorrect lines and then realise this, forcing them to suddenly twist, turn, jump, or land awkwardly in order to avoid being penalised. Having multiple line markings would also create a problem for our young players who are still learning. Grafton Netball Association prides itself on our excellent NetSetGo programme which has led to many players transitioning to full rule competition netball seamlessly. Multiple line markings would be very confusing for these young players, and it would make it more difficult for them to learn.

Maintenance also needs to be taken into consideration. With many different users and uses, will Clarence Valley Council be able to maintain the courts to an acceptable standard? Grafton Netball Association hosts several carnivals each year, which attract players from adjoining regions. We have always attracted teams from more areas than other

Associations and this is mainly due to our excellent facilities and well-maintained courts. Players want to play at carnivals in Grafton. If the standard of the facilities drops, we risk losing interest in our carnivals, as well as risking players from Grafton no longer wanting to participate in our local competitions. Without Representative carnivals we lose revenue that is used to help pay for our Representative players to compete in the Netball NSW State Titles. This is a costly endeavour for players from a low socioeconomic regional area and we attempt to keep costs down for the players so that no-one is excluded due to financial hardship.

It should also be noted that re-classifying the courts as multi-use does not fit within our Strategic Plan (2021-2024). Allowing other uses of the courts, in addition to netball, is a risk that has not been identified in our plan. Not only are there the risks as stated in previous paragraphs, but there is also a risk of our equipment and / or fixings being damaged or stolen if other users are allowed access to our building. It stands to reason that this would be considered a significant insurance risk for Grafton Netball Association. A Risk Assessment for all these would have to have been included in our plan. In addition, other sports / groups were not listed as Key Stakeholders, so were not considered when writing the plan.

Finally, we are opposed to any Council members / employees outside of the Open Spaces and Facilities team being included in sporting facility use or sporting organisation matters. Decisions in these situations should not go any further than the Manager of Open Spaces and Facilities. This team is perfectly able to adequately perform the roles they have been assigned and they need to be trusted to carry out their duties as necessary.



#### 1.2 Population and Demographics

Taken from the 2016 Census, the following figures provide an indication of the population and demographics of the Clarence Valley.

- The median age was 49 years
- Children aged 0-14 years made up 16.4% of the population
- People aged 65 years and over made up 25.7% of the population
- ❖ 83.8% of people were born Australia
- ❖ 74.4% of people had both parents born in Australia
- ❖ 8.9% of people had both parents born overseas
- ❖ 6.4% of people were Aboriginal and/or Torres Strait Islander
- 32% of families were couple families with children
- ❖ 48.4% of families were couple families without children
- ❖ 18.1% of families were one parent families
- ❖ 13% of couple families had both partners employed full-time
- ❖ 5.2% of couple families had both partners employed part-time
- ❖ 17% of couple families had one partner employed full-time and the other parttime
- ❖ 35.8% of couple families had both partners not employed.

#### 1.3 Membership Profile

Association membership is made up of the following categories:

- Senior Players who have / will have reached 18 years of age by December 31<sup>st</sup> in the year of play.
- ii. **Junior** Players who have / will have reached 11 to 17 years of age by December 31<sup>st</sup> in the year of play.
- iii. Net Set Go Players who have reached / will reach up to 10 years of age by December 31st in the year of play.
- **iv. Non-players** Defined as any person acting in a capacity of team coach, team manager, assistant coach, umpire, administrator, official, or other person who is not registered as a playing member.
- v. Players with a Disability (PWD) Defined as any person who holds a valid concession card for a disability pension, or in the case of children under 18 years of age, whose parent / guardian hold a concession card on their behalf.




