About the plunge Art Market:

The plunge art market will be held on Sunday 28 April 2024 at Yamba River Market, Ford Park Yamba. Places at the **plunge** Art Market are limited and offered by expression of interest.

Selection of Artists:

Priority will be given to local artists and producers of original works.

Stall Details and Requirements

As a stall holder you will receive vertical space approximately 2.4m x 1.8m on portable steel fencing. You will be responsible for providing hanging apparatus for your works, which could be in the form of s-hooks, pegs, bulldog clips etc. You will be required to set up your space according to your preferences. Our goal is to have a vibrant space with a full and busy display of original works by local artists.

There will not be table space available, this market is geared towards hanging works. If you need a flat surface to display your work there may be room for a small table. You will need to bring your own and advise prior so space can be allocated accordingly.

Each artist will be required to setup and dismantle their own display and will be responsible for their own sales transactions. CVC and Yamba Markets are providing the space only as part of the **plunge** Art and Culture Festival. Artists will need a public liability insurance policy with \$20,000,000 cover, if you don't have public liability cover please let us know there is some limited access to cover through Yamba River Markets.

This is a plastic free & sustainability-focused event (e.g. prohibited use of plastic shopping bags and paper or plastic promo material) encouraging the use of sustainable, compostable and recyclable or re-usable packaging to be supplied wherever applicable.

Vehicle access is via the Library lane behind Woolli St Hall, between 7:30am and 8:30am. All vehicles must be off the premises by 8.30am. As this is a shared site, no vehicles will be permitted as part of the Art Market.
