1. Background

In 2004, Council decided to undertake a Community Based Heritage Study (CBHS) of the now former Maclean Council area. (104,408 hectares) Joint funding was provided by NSW Heritage Office with a total budget of \$20,000. A CBHS is the study method recommended by NSW Heritage Office and has replaced the 'car window' surveys of the 1980s which tended to identify the more visible and obvious heritage buildings.

A community study draws on the huge bank of local knowledge. It identifies a wider range of items which tell the story of the historical development of the area. These items are considered important to be maintained for future generations.

The former Maclean Heritage Committee was expanded to create a working group of 16 persons involving representatives from four historical societies in the area and other interested individuals. After 18 months of survey work and 13 meetings, a data base of over 400 items was compiled.

Underpinning the study was a requirement for a Thematic History to represent the main historic themes relevant to the study area. The Thematic History provides a synopsis of the historical events that have shaped the development of the area and links these to the items in the study.

Historical themes include: The Physical Environment; Aborigines- the Traditional Owners; European Settlement; The River Commerce and Transport; The Dairying Industry; Sugar Cane; Fishing; Timber; Mining; Tourism and Recreation.

The Study was co-ordinated and overseen with considerable input by Jane Gardiner; Heritage Advisor and Study Co-ordinator.

2 Heritage Assessments and Potential Heritage Listings recommended in Study

The study includes a data base of items which have been investigated and assessed against the standard NSW State Heritage Inventory. This provides a good basis for making decisions about future management of these buildings and places. All the data was entered onto the data base by the co-ordinator Jane Gardiner.

An item can be of heritage significance if it meets one or more of the following criteria:

- o Historical
- o Social
- o Aesthetic/Architectural
- o Scientific/Technical

The criteria for these headings are fully explained in the State Heritage Inventory. After assessing whether the item is significant in the above categories, it is then also assessed for rarity or representativeness.

For example, an item may be *rare* because it is the only or one of few remaining examples of a type of building or structure in the locality, or is noted for the uncommon use of particular materials, etc.

An item may be *representative* because it is a good example of a particular group of items such as school houses, community halls, but this does not diminish it's significance.

2.2 The State Heritage Inventory Data Base

Over the study period, information was collected on over 437 items. This is recorded on the standard State Heritage Inventory data base which is used commonly by all Councils undertaking studies in NSW.

2.3 Study Recommendations

Of the 437 places that were investigated:

- Over half of the items were not considered to be of sufficient significance for formal heritage listing as they had been substantially altered, or lacked information to be considered.
- 191 new items or groups were recommended for listing on the LEP.
- 4 existing heritage items were recommended to be removed from the LEP.
- 6 Conservation Areas were recommended for streetscape and historic village areas, notably
 - o Chatsworth Island village
 - Maclean central area
 - o Brushgrove Village
 - o Harwood Village
 - o Lawrence Bridge Street- Grafton Street Precinct
 - o Yamba, Wooli St.

3. Consultation with Property Owners

Following the data collection, the next step was to consult property owners on the findings of the study. Each property owner of a place recommended for listing received the information about their property and was invited to comment on it, or suggest changes, or additions.

Written notification was sent to approximately 300* property owners of items identified as potential new heritage items as outlined below:

(*many of the 191 items comprised groups of dwellings, hence the increased number of notifications)

- o Letter dated 7th April 2006--notifying of property being identified in a draft list prior to it being considered by Planning and Environment Committee
- Letter dated 21st April 2006 attaching Data sheet and details of formal public exhibition of heritage study and findings.
- o 55-60 phone calls were handled, and advice provided to property owners.
- o Letters (various dates) acknowledging receipt of written submissions
- o Letter dated 4th October advising of consideration of submissions by Council.

The most important element when advising property owners of a draft listing was to ensure that they were adequately informed. There tends to be a public perception that an owner is not able to do anything with a property that is heritage listed. This is not the case and information was provided to owners to inform them of the facts.

The main objective with a heritage item is to ensure that the item remains intact, retains its significance, and continues to be maintained.

For this to happen, it is important to ensure that the place can continue to be used and sympathetic alterations may be required to enable this to occur.

Heritage listing may sometimes expand the options available for uses, as the planning provisions can allow uses that are otherwise not allowed in a zone or waiving parking requirements, in the interests of conservation.

An information sheet about heritage listing (included in the study report) accompanied the letter sent out. Council's Heritage Officer also met and talked to over 50-60 owners about these matters and discussed some specific proposals.

4. Formal Public Exhibition

The Maclean Heritage Study and Thematic History were placed on public exhibition for 2 months from Monday 1st May April 2006 to Friday 30th June 2006. Copies were available in all public libraries and at Council offices. The full data sheets were displayed in the Maclean Office and an electronic copy was available in the Grafton office.

4.1 Copy of Advertisement

Maclean Community Based Heritage Study

During the past two years, Council has carried out an extensive heritage study of the former shire area, with valuable assistance from local community members.

The study includes a thematic history, a main report which matches heritage items to the historic themes, and a data base of over 400 items and conservation areas which have been investigated and researched.

The main thrust of the study is to identify those places and buildings which the community value and wish to be retained to future generations. 191 of the items investigated are considered to have potential for heritage protection and are itemised in the main report.

This information is on public exhibition at the Maclean Council Offices 50 River St, Maclean from Monday 1st May April 2006 to Friday 30th June 2006

Copies of the Main Report and Thematic History will also be available at the Maclean, Yamba, Iluka and Grafton Public Libraries.

The exhibition period was extended to 15th July 2006 for property owners to enable them plenty of time to prepare a submission.

5 Summary of Results of Exhibition and Consultation.

228 No objections, or no comments.

These include, individual private and government items, some items nominated by owners for listing, and non listed properties which have received heritage grants.

Written submissions were reviewed. (14 non objections, 45 objections.)

- O A review of the issues raised in relation to each property is provided in a separate report at **Appendix 1**. This includes comment on the points raised in the submission and comments specific to the property. It concludes with a recommendation on whether the property should continue to be considered for heritage listing or removed from the draft list.
- o The original submissions can be viewed on request at Council offices.

55-60 Phone Enquiries were handled and advice was given to property owners.

Of these, 34 did not raise an objection or were neutral about the proposal or were seeking further explanation, and 18 followed up with written objections which are included above.

Conclusion

Overall, there were **45 objections out of 300 properties** canvassed which indicate very strong overall support for the process and intentions of the Maclean Heritage Study.

6. Discussion of Issues Raised

6.1 Public Authority/Government or Council- owned items of Heritage Significance

These include

- o Public buildings, (eg Yamba Police Station, Maclean Showground)
- o Reserves, (eg Flinders Park, Angourie Point)
- o Commons, (Brushgrove Common)
- o Natural features, (eg Iluka Sea Stack,)
- o other infrastructure, (Ashby Dry Dock,)
- o Cemeteries, (Maclean, Lawrence, Small family)
- o Community halls,(eg Harwood Water Brigade Hall)
- o War memorials, (eg Chatsworth Yamba, Maclean,) and
- o Significant tree plantings (eg Wooli St, Chatsworth Island, Harwood)

No objections were raised to the inclusion of these publicly owned items in the Heritage List.

It is appropriate that they should be protected and conserved.

Inclusion of these items will provide increased information and awareness to Council and other public authorities who are responsible for maintenance and care of these important items.

This accounts for 60 proposed heritage items.

6.2 Privately owned places of Heritage significance.

No objections were received in relation to **165** items. (Some of these are part of larger groups). This indicates considerable support for the study and protection of heritage places/ items.

Objections

Of the objections received, the main issues of concern were:

- a) Loss of redevelopment potential with the view of demolition in the long term, mainly in relation to the cottages identified in Yamba which are mostly zoned for medium density development.
- b) Concern about restrictions on carrying out work to buildings in the future
- c) Lack of support for heritage listing because the property had been altered/including unsympathetic additions.(This mainly related to items which were part of group listings, but retain their scale and form)
- d) Possible loss of property value and impact on resale in the future
- e) Some general objections to listing without any reasons provided.

Comment

(a) Concern about Loss of Redevelopment Potential

This issue has been raised primarily in relation to small cottages in Yamba, mainly within the 2(b) zone with high land values. Many of the remaining old holiday cottages are flanked by modern units and multi unit development. It is considered inequitable in this circumstance to place a heritage listing on these cottages, (some of which were removed to the sites as low key holiday accommodation from other places).

This issue is not relevant to areas such as Maclean where most of the older housing stock is located in low density residential zones, and has a maximum of dual occupancy development potential, if the allotment size is 800 m2 or more. Development of a dual occupancy or second dwelling at the rear may be quite feasible on the larger allotments and would not impact on the streetscape if access is obtained via the laneways, and the design is sympathetic.

The streetscapes in Maclean, Brushgrove and other older settlements are far more intact, with the new development being more out of character than the older buildings. It is therefore considered that these areas have considerable value in being retained, not only for the individual buildings but for whole streetscapes.

These tree lined streets of timber and iron houses are irreplaceable, in the context of modern subdivisions and development. There is still opportunity for sympathetic infill development and additions to enable these houses to continue to be used and enjoyed with modern standards. Making a positive decision to protect these areas provides residents with more certainty about the future of the area and can increase land values.

(b) Concern about restrictions on carrying out new work and alterations, and (c) Lack of support for heritage listing because the property had been altered/including unsympathetic additions. (This mainly related to items which were part of group listings, but retain their scale and form)

With regard to objections about control over carrying out work and alterations, there is a common <u>myth</u> among the general public that owners "are not allowed to do anything" to a heritage property.

Extensions, pools, garages and sheds, etc *all require development consent* regardless of whether the property is heritage listed or not.

As stated earlier, the main objective with a heritage item is to ensure that the item remains intact, retains its significance, and continues to be maintained. It is important that a place/building can continue to be used, and sympathetic alterations may often be required to enable a building to be extended or meet modern standards.

Therefore alterations and extensions are permissible provided that they are sympathetic to the significance and character of the item. There are some small scale 'exempt' developments such as cubby houses, small garden sheds, aviaries, shade sails, etc which are allowed without consent on a regular house, but these are still permissible with consent on heritage items. The purpose of this is to ensure that alterations and additions are sympathetic to the building and streetscape.

Some objections were lodged about buildings being included in groups, which have been substantially modified from their original details. These were included because their general scale and form is still consistent with the group and overall they help to maintain the streetscape character. Sympathetic restoration in the future would return the full value to these buildings.

However, after assessment of the submissions, it was considered that a few examples have reduced integrity are recommended to be deleted from the groups. A new replacement building which is sympathetically designed could be considered in the future subject to it maintaining the same scale, roof pitch and general form. This is a critical issue when addressing new development in heritage precincts.

(c) Concern about Loss of Property value

The issue of loss of property value was raised in several submissions, mainly in relation to Yamba, but also to some other properties in Maclean. This point is accepted in Yamba in relation to the remaining cottages on Yamba Hill which are located in a precinct of very high land values with multi unit development potential, and often flanked by modern units. However in other areas, no conclusive evidence was supplied with the submissions to justify this point.

Various studies and surveys about heritage listing and house prices have been undertaken in the past. These have generally concluded that where cohesive streetscapes with historical character are maintained by positive controls, such as heritage listings and Conservation Areas, it provides residents and future investors certainty about the future of the neighbourhood. Consequently values tend to be high in such areas. * (1)

Another report in November 2005 confirmed that residential and commercial studies have demonstrated that property values have not been negatively affected by Heritage listing, (ie; the impact has been neutral or positive).* (2)

Another study * (3) concluded that economic viability is dependent upon pre-emptive market factors which are not generally related to heritage considerations. Heritage listing did not deter project commitment by developers in the case studies, and did not negatively affect the performance expectations of the projects.

Finally, the recent NSW Productivity Commission Report in April 2006 * (4) looked at this issue and compared two different local government areas with price modelling. It concluded that in both Council areas; Parramatta and Ku-ring-gai that heritage listing did not have a significant effect (positive or negative) on the value of housing when structural and locational attributes are taken into account.

7. Recommendations

The draft LEP will be required to undergo the required public exhibition period and period for submissions Owners will be advised of the planning process and notified of the exhibition period.

8. Ongoing Heritage Management

The report includes numerous heritage management recommendations for Council to continue to undertake, or to implement which flow on from the study.

8.1 Continuation of the Local Heritage Fund

This is a local grants program which is funded 50% by NSW Heritage office and 50% by Council. It enables owners of heritage buildings or places to access small grants to assist with conservation and maintenance, and reinstatement of missing elements. The grants are generally \$2,000 but can be increased for community used halls or churches etc.

This grant programme has been running successfully since 2001.

8.2 Access to Heritage Advice and pre -Development Advice.

Owners and applicants are strongly encouraged to consult with Council prior to carrying our works. Advice is often obtained for works that do not require consent but can have an impact on the building eg maintenance and repairs. It is important to use correct materials and techniques which are sympathetic are important in retaining heritage significance of older buildings.

Obtaining heritage advice from Council's heritage officer prior to preparing plans allows issues of concern to be identified at an early stage and alternative options explored. Advice on development in proximity to heritage items is also important.

8.3 Heritage Committee

A new Clarence Valley Heritage Advisory Committee has been established and is keen to promote and protect heritage in the valley. The committee are keen to have an input into major proposals and have been consulted on a several proposals since it commenced in August 2006.

8.4 Incentives

Development application fees were waived for the Maclean Main Street restoration development applications and this was an additional incentive to assist owners to carry out the conservation and reconstruction work. Consent is needed for changes or alterations and in many cases this will increase heritage significance by reinstating what previously existed.

It is recommended that DA fees be waived for owner of heritage listed properties where consent is needed to carry out work which will contribute to the conservation of the property such as reinstatement of verandahs, and missing details, etc.

8.5 Rate Incentives

Council could also consider reducing rates on heritage listed properties where properties are being well maintained. The Valuer General is also has the ability to make a heritage restricted valuation on request from an owner.

Recommended that Council investigate Heritage rate incentives

8.6 Special Projects

As outlined in the main report to the study, several projects have been identified as requiring particular attention.

- o Restoration of the cane punt, Ferry Park,
- Restoration of the school masters residence ,Wooli St (owned by Yamba Bowling club)
- o The small family cemetery
- o Sarah Phillips Headstone
- o Walking guide to Wharf street
- o Development of specific Policy guidelines for the Conservation Areas.
