Eligibility

All businesses that are based within the Clarence Valley Council area at the time of nomination are eligible to enter or be entered. You may nominate a third party or self nominate for an award.

Selection Criteria

The aim of the Award is to recognise outstanding contributions or achievements by a business that enhances environmental, economic and social sustainability. The judging panel will be looking at the length, quantity and quality of the contribution/achievement. If further information is required for judging purposes, a committee representative/s may contact, visit and or take additional photos via arrangement.

The Awards Process

- 1. Entries will be judged by the Clarence Valley Council Climate Change Advisory Committee. The judges' decision will be final and no correspondence will be entered into.
- 2. All nominations must be received by Clarence Valley Council before **4pm Monday September 26 2022**. Please note that late nominations can not be accepted. No correspondence will be entered into regarding late submissions.
- 3. Winners will be awarded at a special awards ceremony to be held in **December 2022**.
- 4. The information collected in this nomination form will be used by Council only for the purpose of considering and selecting the recipients of Council's Living Sustainably Awards and in the promotion and announcement of the awards.
